MAP - "Multi-Stakeholder Partnership for an Energy Transition in Kosovo" is a project implemented by Balkan Green Foundation and Germanwatch. The project aims to tackle Kosovo's energy system's transition, particularly its electricity system, towards a more sustainable state, increasing the share of renewable energy and improving local energy efficiency.


The project effectively fosters a local multi-actor partnership as an ideal means to create resonance and support from key local actors, to develop their vision of a sustainable energy transition as a shared societal project. The project aims to transfer knowledge amid key local actors and other experienced knowledge carriers from around Europe to enable Kosovo to leapfrog on lessons learned in implementing sustainable energy transitions and integrate climate change measures into national policies, strategies, and planning.

GREEN CROSS

"GREEN CROSS – Towards Local Green Economies with Smart Investments in the Municipality of Kline and Has" project is a crossborder project implemented in Albania, Has Municipality, and Kosovo, Municipality of Klina.

It aims to contribute to an overall sustainable economic growth in the cross-border region by enabling transition of municipalities into the sustainable green economy through integrated policy, smart public investments, and capacity development.

This project is under the Cross Border Cooperation (CBC) Programme for Environment between Albania and Kosovo.



SNAPSHOTS OF 2020

Work on the development of twinning Green Smart Investments Action Plans for two Municipalities is underway.

1 participatory workshop was held in Klina, to include the Municipality of Klina in the development of Green Smart Investments Action Plans to incorporate the financial benefits and green planning into local governance.

Over 650 LED indoor light bulbs were purchased to be installed in the Municipality of Has's publicly owned buildings (schools, hospitals, governmental buildings, etc.)

220 LED lamps with dimming systems for outdoor installments in Has Municipality are installed on the municipality's main road.

Planifications have commenced installing 800 LED lamps with dimming systems for indoor spaces and 15 outdoor LED lamps in Klina Municipality in early 2021.

Contributed to increased awareness on energy efficiency and a healthier, greener environment through various information dissemination outlets like social media channels and national media, where the importance of sustainable investments was emphasized.

GREEN RURAL DEAL

Green Rural Deal is a project initiated at the end of 2020 between Balkan Green Foundation, Wuppertal Institute, Germanwatch, Regional Association of Local Government of Western Macedonia and RES Foundation. The project's objective is to develop local capacities for a transition to a zerocarbon economy in three target regions: Western Macedonia (Greece), Kamenica (Kosovo), and Priboj (Serbia).

The project aims to support and empower municipalities in rural regions in the said countries in exchange with German municipalities through local capacity building, peer-to-peer learning and co-creation of concrete projects.

The Green Rural Deal will produce recommendations for each target region and work with core stakeholders in each region to co-create sustainable projects and strategies.



Balkan Energy Prospect is among the tools created by BGF to promote public understanding of the energy flow and its interaction with the economy and the environment.

This regional mapping platform provides a visual representation of data regarding efficient electricity access and connection of strategies within the Western Balkan (WB) region that will drive the cooperation process and contribute regionally towards the advancement of their energy systems, guided by the shared commitments, obligations, and targets of the Energy Community Treaty.

With the establishment of cooperation and integrated energy infrastructure, countries will increase cross-border collaboration, develop regional projects, and lower their carbon economy.

As such, this platform provides valuable information about six (6) WB countries in terms of their energy technologies, potential synergies for a future integrated energy market, and capacities for energy diversification within the WB region.

Each year the academy is educating future Balkan Green Ideas applicants about green initiatives and sustainable development.

REGIONAL INCUBATOR FOR SOCIAL EN-TREPRENEURS (RISE)

RISE project supports young change-makers in developing their impactful ideas into sustainable social businesses. The objective of the project is to address a specific and crucial need in the region in relation to its current context and history: opening new spaces of reconciliation for the youth of the Western Balkans through social entrepreneurship.

The project, due to its very regional nature, will tend to increase the number of crossborder interactions around social entrepreneurship during the 3 years of the project and thereafter.

The tailor-made support program is developed and monitored by the Consortium: RYCO, GROUPE SOS Pulse, SEEYN, the Institut français, and the Franco-German Youth Office (FGYO)

EMPOWER - ENGAGE -BUILD OWNERSHIP

The end of 2020 marks the successful conclusion of the three-year project between 'Empower - Engage - Build Ownership' implemented by Balkan Green Foundation (BGF) in cooperation with Institute for Development Policy (INDEP). The project aimed to enable Kosovo's civil society sector to fulfill its role in the democratic environment by acting as independent interlocutors, monitoring public institutions, increasing accountability and transparency in policy development and decision making processes regarding concerns of communities and civil society groups in the area of environment preservation, green energy and sustainable economic growth.

RESEARCH SNAPSHOTS

Implementation of Energy Efficiency and Renewable Energy Policies and **Requirements within the SAA, ERA and ERPS**

This publication provides an analysis of the National Programme for Implementation of the Stabilization and Association Agreement (NPISAA) and its interconnection with the ERA and ERP in the realm of progress in energy efficiency measures and renewable energy sources. It does provide information on the monitoring process, performance, and efficiency of Kosovo's fulfillment and provides concrete recommendations about what steps should be taken by the Government of Kosovo to fulfill its part of the agreement with the EU.

Improvement of Public Procurement Standards to Increase Energy Efficiency in Kosovo

This research paper aims to raise awareness among central and local administration authorities, to promote the amendment and implementation of the Law on Public Procurement in purchasing only products, services and buildings with high energy efficiency performance, as well as to push forward Energy Performance Contracts (EPCs), establishing a convenient environment for the development of ESCOs. The results indicate that these institutions face different issues which make it impossible to implement Energy Service Companies (ESCOs), and delays are occurring in the fulfillment of goals and obligations arising from the Energy Community Treaty (ECT).

SUSTAINABLE DEVELOPMENT IN DEVELOPMENT POLICIES AND **INVOLVEMENT OF ACADEMIA**

The purpose of this research is to analyse the inclusion of the concept of sustainable development in the policy development documents of Kosovo, as well as the component of the inclusion of education and scientific research in the sustainable future of the country. The main research question is how much the concept of sustainable development and the science of sustainability is included in the country's strategic development documents.







Recommendations – Security of Supply in the Energy Transition in Kosovo

The objective for drafting this recommendations paper is to support the government of Kosovo in the implementation of government plans for a RES phase-in – especially for drafting the revision of the Energy Strategy, the National Energy and Climate Plan (NECP) and the concept for RES development. The paper consists of 11 Strategic Recommendations, 14 concrete policy steps and 9 practical/technical measures. It has been drafted, jointly agreed upon in 2019 and updated in Oct 2020 by the core team of a multi-actor-partnership, which consists of experts/important actors of the Kosovo energy sector, that are active in energy and sustainable development.

Phasing in Renewables – Towards a Prosperous and Sustainable Energy Future in Kosovo: Challenges and Possible Solutions


This study focuses on the challenges that need to be faced in order to phase in renewables and phase out lignite. It provides evidence and inspiration from other countries that have tackled such challenges already. The solutions proposed in this study are intended to serve as a basis for discussion and inspiration on how these manifold challenges can be faced.



Hydropower Plants in Kosovo the Problems and their Real Potential

This document analyses portraits the overall situation of the hydropower sector in Kosovo and assesses its real potential of these projects. The analysis mentions the existing hydropower plants, the ones planned to be constructed, their problems and the real impact on the environment and concerns of local communities regarding these constructions. This research concludes that hydropower plants have problems and negative impacts mainly on the social, political, economical and environmental domains.





LOCAL AND INTERNATIONAL **ADVOCACY 2020**

BGF represents the Western Balkans region at the roundtable on Environmental Human Rights

BGF represented the WB region at the European level roundtable, held under the patronage of the Commissioner for Human Rights of the Council of Europe. The roundtable brought together environmental activists to disclose barriers faced by environmental human rights defenders and activists working on issues related to the environment.



BGF part of the Regional Youth Leadership Forum

BGF emphasized the need for an integrated approach in implementing the Common Regional Market Action Plan, by involving the existing mechanisms in place in all WB6 countries, such as CSOs. business communities, and institutions through the process to ensure strengthening of the existing structures and avoid overlapping and repetition of the present initiatives.



BGF part of 'Energy Democracy in Kosovo' Green Talk by DokuFest

Discussions examined the role of power and politics in the existing regime that resists the integration of renewable energy as an energy source, as well as the ability to encourage the manifestation of energy democracy and how this may affect the search for change in infrastructure for the transition to clean and sustainable energy.

BGF gave emphasis to issues pertinent to the energy sector in Kosovo, while underlining the importance of the role of Green Caucus to increase the level of transparency as well as to represent the public interest.

Organized by the Assembly of Kosovo and South East European Cooperation Process (SEECP), the conference brought together representatives from countries from Southeastern Europe and discussion spanned over

three thematic areas namely the environment. EU accession process of the Western Balkans, and labor force migration offering a platform for comprehensive coverage on current matters.

During the discussions, BGF stressed the importance of active contribution from the Western Balkans to European strategies and policies and provided solutions for a sustainable and environmentally friendly region. BGF also emphasized the need for a greater political will to achieve goals on carbon emission and climate change neutrality and a more robust governance for a just transition in the Western Balkans.

REFLECTING **ON BGF'S** MAIN **EVENTS**

During the last seven years, Balkan Green Foundation has continuously worked on advocacy and awareness raising initiatives concerning Kosovo's and the region's sustainability issues, particularly focusing on the country's energy transition path and its progress towards sustainable development. This has been done by organizing and initiating numerous events, workshops, meetings, forums and conferences, where members of the public sector, civil society, international organizations and field experts were gathered to discuss and debate the issues, challenges and opportunities for Western Balkans path towards sustainable development. energy transition, and environmental protection.

ANNUAL **HIGH LEVEL CONFERENCES:**

2019: Annual High Level **Conference on Energy Transition** in Kosovo - "Energy for the Future"

Balkan Green Foundation organized the discussion with the theme "Energy for the Future". During this conference specific focus was given to the overall energy situation in Kosovo, the challenges, general directions, the development trends, energy efficiency, renewables, the potentials but also challenges in this sector including the successes achieved in the energy transition, effectively identifying ways to embrace a decarbonized future in the energy community.



2018: Annual High Level **Conference on Energy** Transition - "Challenges and **Opportunities in Kosovo and** the region"

Balkan Green Foundation organized a Conference on Energy Transition with the theme "Challenges and Opportunities in Kosovo and the region". The focal point of this conference was the discussion on the relation between the region's dependency on fossil fuels and the importance of prioritizing diversification of the sources of energy in the energy development agendas, where sustainability, reliability and affordability should be the cornerstones of their policies on energy.



2016: Western Balkans Sustainable Policies towards **EU** integration - Regional Conference

Balkan Green Foundation (BGF), in collaboration with the Rockefeller Brothers Fund and the European Office in Kosovo/ EUSR, organized a high-level regional conference to discuss matters regarding sustainable development, climate change, and Western Balkan countries' pathway towards Europe. The conference tackled energy, climate change and environmental policies, in the context of the Western Balkans.



THREE ANNUAL SUSTAINABILITY FORUMS

For three years in a row, BGF and the Energy Community in cooperation with other partners (Heinrich Böll Foundation, The Nature Conservancy and RES Foundation) organized the Sustainability Forum to discuss the best ways for the Energy

Community to embrace a decarbonized energy future.

2019

In 2019, the participants at the Forum mainly expressed concern regarding the delay in the establishment of a new 2030 Energy Community legislative framework to increase substantially the share of energy from renewable sources, especially wind and solar, improve energy efficiency and reduce greenhouse gas emission, in accordance with the Paris Agreement.



2018

In 2018, the main focus of the Forum was on the best ways to shape energy and climate policy in the Energy Community.







2017

At the first Sustainability Forum which was held in 2017. focus was given to the best ways to contribute towards a lowcarbon transition of the Energy Community.



EUROPEAN PARLIAMENT

2018: Balkan Green Foundation organized a discussion on Western Balkans and its climate ambition

Balkan Green Foundation organized a discussion held in Brussels with a focus on: "Western Balkans and Ukraine: EU's Role in Modernization through higher Climate Ambition". The discussion panel focused on the issues pertaining to Western Balkan countries and Ukraine facing a number of profound transformation challenges, where climate policy and energy sector reforms can be a key for progress.



2015: Conference On Challenges Of Western Balkan's Energy System

Balkan Green Foundation (BGF) led discussions at the event hosted by Ulrike Lunacek, Vice-President of the European Parliament, on the potential of the countries of the Western Balkans to modernize their economies and energy systems to make them fit-for-purpose in a future sustainable and renewable economy.

ANNUAL MEETINGS OF THE INTERNATIONAL MONETARY FUND (IMF) AND WORLD BANK (WB)

Balkan Green Foundation throughout the years has participated in several IMF and WB annual meetings. Above all, BGF during these meetings has continuously advocated against WB's support for the 'New Kosovo' Coal Plant and has endorsed and raised awareness on supporting green projects instead.



Among different interactive events, BGF's executive Director, Visar Azemi, once brought about the issue of the new coal plant in Kosovo and addressed a question to the president of the World Bank, Jim Yong Kim, regarding the WB's position on supporting coal in Kosovo, where the latter confirmed that the World Bank has made a very firm decision to not support the "New Kosovo" coal power plant in Kosovo.

This was the first time that this WB's decision was made official to the public.

LEGAL ACTIONS

NGOS WIN FOURTH LAWSUIT AGAINST MINISTRY OF ECONOMY AND ENVIRONMENT FOR ACCESS TO PUBLIC DOCUMENTS

On 8 June 2020, Balkan Green Foundation, GAP Institute, Group to Legal and Political Studies, and the Institute for Development Policy, on the basis of the law on Access to Documents Public and Judgment of the Court of Appeal of Kosovo, have re-sent the request for access to official documents to the Ministry of Economy and Environment, for the project that already failed, the power plant 'Kosova e Re'.

Specifically access was re-asked for: (1) final call for application sent to prequalified companies and (2) changes in the tenders package that have occurred from the first call for pre-qualification until the selection of bidders and the reasons for changes in the package.

The court decision on granting access to these documents guarantees the interest of citizens and the right of them to be informed, and stands true to BGF's commitment for transparency. This is the fourth verdict giving rights to NGOs for access to the public documents, which have illegally been kept secret by the MED.



PENAL OFFENSE FILED AGAINST MESP SECRETARY FOR BADOVC LAKE AREA

Balkan Green Foundation (BGF), Group for Legal and Political Studies (GLPS), Institute for Development Policy (INDEP) and GAP Institute, on 31st of January 2020, filed a criminal report against the Secretary General at the Ministry of Environment and Spatial Planning (MESP) for its actions regarding the case of construction in the Badovc Lake area.

Lake Badovc, for business/residential purposes accounting for its strategic importance for the security of drinking water supply and for an ecological environment for citizens of Pristina and beyond.

BGF, GAP, GLPS and INDEP stood against this project and called on the Ministry of Environment and Spatial Planning (MESP) and Pristina authorities to:

To reject and revoke all permit applications for the implementation of this harmful plan for the sustainable development of the capital and beyond.

To stand for the protection of the public interest mandated by the laws in force and the Constitution.

Not to approve a project that further suffocates public spaces, contradicts country legislation on the protection of water resources, adversely affects the environment and biodiversity, and causes Pristina and its surroundings to lose even that little greenery that's left and fades the citizens opportunity to visit Lake Badovc.

Resultant of these actions, this joint proceeding managed to attain justice on the matter and ensure protective measures for the Badovc surface water source.
